Hosts, and I covenant not to sue, and waive and release the Hosts from any and all responsibilities of personal injury
to me.
I hereby waive any and all claims whatsoever that I or anyone else on my behalf may or could make with
respect to such injury or damages. I further understand and agree that I will hold the Hosts harmless for any
liability for any injuries, damages, etc. caused by me to other participants in or attending this paintball program,
including the Hosts, which is caused in whole or in part by any of my acts, including negligent acts.
I agree for myself and successors, that the above representations are contractually binding, and are not mere recitals,
and that should I or my successors assert my claim in contravention of this Agreement, I or my successors shall be
liable for the expense (including, but not limited to, legal fees) incurred by the other party or parties are finally
adjudged liable on such claim for willful and wanton negligence. This agreement may not be modified orally. A
waiver of any provisions of this Agreement shall not be construed as a modification of any other provision, or as a
consent to any other subsequent waiver or modification. I have fully read, understand and agree to everything stated
